

## **PROCEEDINGS OF THE TERREBONNE PARISH SCHOOL BOARD**

**AUGUST 21, 2018**

The Terrebonne Parish School Board met today at 6:00 P.M. in regular session at its regular meeting place, the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana, with Mr. Roger Dale DeHart, president, presiding, and the following members present: Ms. Vicki Bonvillain, vice president, Mr. Roosevelt Thomas, Mr. Richard Jackson, Mrs. Debi Benoit, Mr. L. P. Bordelon, III, and Mr. Donald Duplantis.

ABSENT: Mr. Gregory Harding and Dr. Brenda Leroux Babin

Mr. Jackson led the Board and audience in the invocation and Pledge of Allegiance to the Flag.

A moment of silence was observed in memory of Rita T. Bourgeois, retired school teacher; Dorothy R. Davis, retired school teacher; Idola P. Marcel, retired school bus operator; John R. Moise, retired school teacher; Sandra B. Chauvin, retired school teacher, and Lorraine Ruffin, retired paraprofessional, who recently passed away.

President DeHart recognized Mr. Nelson Kramer, former Terrebonne Parish School Board Member, who was in attendance at tonight's meeting.

Dr. Brenda Leroux Babin and Mr. Gregory Harding entered the meeting at this time.

The following report of the Buildings, Food Service, and Transportation Committee Meeting was presented to the Board with Mr. Jackson, chairman, presiding:

**The BUILDINGS, FOOD SERVICE, and TRANSPORTATION COMMITTEE** met at 5:00 P.M. on Monday, August 13, 2018, in the Board Room of the School Board Office with the following members present: Mr. Richard Jackson, chairman, and Mr. L. P. Bordelon, III, vice chairman. Mr. Gregory Harding was absent. Also in attendance were Mr. Donald Duplantis, Mr. Roger Dale DeHart, Board president, Mrs. Debi Benoit, Mr. Roosevelt Thomas, Superintendent Philip Martin, and members of the staff.

Chairman Jackson called the meeting to order. The meeting began with the invocation and Pledge of Allegiance to the Flag.

Mr. Louis Liner, Coach of the Impact Sports 12 year old boys' baseball team, addressed the Committee regarding the use of Southdown Primary School's baseball field, in Dularge, by Impact Sports baseball team.

#### **RECOMMENDATION NO. 1**

**The Committee recommends** that the Board grant the request of the Impact Sports 12 year old boys' baseball team and waive Policy FILE: E-1.6 Use of Facilities, relative to the usage fee for Southdown Primary School's baseball field, in Dularge, from August 2018 to August 2019, from 4:30 P.M. to 7:30 P.M. daily, provided that the necessary insurance, non-profit status, and all other School Board policy requirements are met; and approval is obtained from the school's principal.

Mr. Harding entered the meeting at this time.

**The Committee recommends** that the Board allow the Superintendent to begin exploring an addition to Mulberry Elementary School.

Substitute motion of Mr. DeHart, seconded by Ms. Bonvillain, with the exception of Dr. Babin and Mrs. Benoit who objected, the Board allowed the Superintendent to begin exploring an addition to Mulberry Elementary School and appointed Mr. Merlin Lirette, The Merlin Group, Ltd., as the project architect.

### **PROCLAMATION**

**Whereas** our Founding Fathers, in order to secure the blessings of liberty for themselves and their posterity, did ordain and establish a Constitution for the United States of America;

**Whereas** it is of the greatest importance that all citizens fully understand the provisions and principles contained in the Constitution in order to support, preserve, and defend it against all encroachment;

**Whereas** the two hundred thirty-first anniversary of the signing of the Constitution provides a historic opportunity for all Americans to realize the achievements of the Framers of the Constitution and the rights, privileges, and responsibilities it affords; and

**Whereas** the independence guaranteed to American citizens, whether by birth or naturalization, should be celebrated by appropriate ceremonies and activities during Constitution Week, September 17 through 23, as designated by proclamation of the President of the United States of America in accordance with Public Law 915; now, therefore, be it

**Resolved** that the Terrebonne Parish School Board, in conjunction with the Bayou Lafourche Chapter of the National Society, Daughters of the American Revolution, does hereby proclaim the week of September 17 through 23, 2018, as "Constitution Week" in the schools of Terrebonne Parish and does urge all students to study the Constitution, and reflect on the privilege of being an American with all the rights and responsibilities which that privilege involves; be it further

**Resolved** that copies of this proclamation be forwarded to all Terrebonne Parish public schools and office buildings.
