

# PROCEEDINGS OF THE TERREBONNE PARISH SCHOOL BOARD

February 1, 2022

A Public Hearing was held this date at 6:00 P.M. in the Board Room of the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana to receive comments from the public as it relates to the following resolution (Alternative 1-A) which would establish and define the Terrebonne Parish School Board 2021 election districts in accordance with Federal and State Statutes:

## **A RESOLUTION TO ESTABLISH AND DEFINE THE TERREBONNE PARISH SCHOOL BOARD 2021 ELECTION DISTRICTS IN ACCORDANCE WITH FEDERAL AND STATE STATUTES**

### **Section I.**

**WHEREAS**, as specified in Louisiana Revised Statutes 17:71.1 the Terrebonne Parish School Board is required to redraw the boundaries of the voting districts every ten (10) years in accordance with the decennial census; and,

**WHEREAS**, the Census was taken in 2020, and the population data was released by the Census Bureau in August of 2021; and,

**WHEREAS**, boundaries of any election district for a new apportionment plan from which members of a school board are elected shall contain whole precincts established by the parish governing authority; and,

**WHEREAS**, if a school board is unable to comply with applicable law regarding redistricting and reapportionment, including adherence to traditional redistricting principles, in the creation of its redistricting or reapportionment plan through the use of whole precincts, the school board may, in the creation of its redistricting or reapportionment plan, divide a precinct into portions which are bounded by visible features which are census tabulation boundaries. No such precinct shall be divided into more than two school board districts. No school board district shall contain more than three divided precincts; and

**WHEREAS**, the Terrebonne Parish School Board has examined, reviewed, and considered various alternative alignments based upon the findings of the United States Department of Commerce, Bureau of the Census; now

**THEREFORE, BE IT RESOLVED**, that the Terrebonne Parish School Board establishes the considered map alignment entitled **Alternative 1-A**, and that the aforementioned districts are hereby established:

### **District 1**

District 1 contains all of precincts 71 and portions of 29, 31, 34, 35, 36, 38, 41, 46, 48, 52, 72, and 111 described as follows:

#### **Precinct 29**

Beginning at the point of intersection of the centerlines of Louisiana Highway 659 (East Park Avenue) and Louisiana Highway 3087 (Prospect Boulevard); thence proceeding southeasterly along the centerline of Louisiana Highway 659 (East Park Avenue) to its intersection with the centerline of Olympe Drive; thence proceeding southerly along the straight centerline extension of Olympe Drive to its intersection with the center flow channel of Bayou Terrebonne; thence proceeding northwesterly along the center flow channel of Bayou Terrebonne to its intersection with the centerline of Louisiana Highway 3087 (Prospect Boulevard); thence proceeding northerly along the centerline of Louisiana Highway 3087 (Prospect Boulevard) to its

intersection with the centerline of Louisiana Highway 659 (East Park Avenue), the point of beginning.

### **Precinct 31**

Beginning at the point of intersection of the centerline of Louisiana Highway 3087 (Prospect Boulevard) the center flow channel of the Intracoastal Canal; thence proceeding easterly along the center flow channel of the Intracoastal Canal to its intersection with the straight line extension of Browning Court; thence proceeding southwest along the straight centerline extension of Browning Court and the straight centerline extension of Browning Court between 9778 and 9788 East Park Avenue to its intersection with the center flow channel of Bayou Terrebonne; thence proceeding northwesterly along the center flow channel of Bayou Terrebonne to its intersection with the straight line extension of Olympe Drive; thence proceeding northeast along the straight line extension of Olympe Drive to its intersection with the centerline of Louisiana Highway 659 (East Park Avenue); thence proceeding northwesterly along the centerline of Louisiana Highway 659 (East Park Avenue) to its intersection with the centerline of Louisiana Highway 3087 (Prospect Boulevard); thence proceeding northeast along Louisiana Highway 3087 (Prospect Boulevard) to its intersection with the center flow channel of the Intracoastal Canal, the point of beginning.

AND

Beginning at the point of intersection of the centerline of Louisiana Highway 3087 (Prospect Boulevard) and the center flow channel of Bayou Terrebonne; thence proceeding easterly along the center flow channel of Bayou Terrebonne to its intersection with the straight centerline extension of Garden Lance; thence proceeding southerly along the straight centerline extension of Garden Lance to its intersection with the centerline of Louisiana Highway 24 (East Main Street); thence proceeding westerly along the centerline of Louisiana Highway 24 (East Main Street) to its intersection with the centerline of Louisiana Highway 3087 (Prospect Boulevard), the point of beginning.

### **Precinct 34**

Beginning at the point of intersection of the centerlines of Furman Street and Louisiana Highway 57 (Grand Caillou Road); thence proceeding easterly along the centerline of Furman Street to its intersection with the centerline of Myrtle Street; thence proceeding southerly along the centerline of Myrtle Street to its intersection with the centerline of Morris Street, thence proceeding easterly along the centerline of Morris Street to its intersection with the centerline of Double Court; thence proceeding southerly along the centerline of Double Court to its intersection with the centerline of Fielders Court; thence proceeding southeasterly and northerly along the centerline of Fielders Court to its intersection with the centerline of Effie Street; thence proceeding easterly along Effie Street to its intersection with the centerline of Judith Street; thence proceeding northerly along the centerline of Judith Street to its intersection with the centerline of Tony Street; thence proceeding easterly along the centerline of Tony Street to its intersection with the centerline of Jackson Street; thence proceeding southerly along the centerline of Jackson Street to its intersection with the centerline of Morris Street; thence proceeding easterly along the centerline of Morris Street to its intersection with the centerline of Louisiana Highway 661 (Howard Avenue); thence proceeding northerly along the centerlines of Louisiana Highway 661 (Howard Avenue) and the Howard Avenue Bridge to its intersection with the center flow channel of Bayou Terrebonne; thence proceeding southeasterly

along the center flow channel of Bayou Terrebonne to its intersection with the centerline of Prospect Boulevard Bridge; thence proceeding southerly along the centerlines of the Prospect Boulevard Bridge and Prospect Boulevard to its intersection with the center flow channel of Bayou Chauvin; thence proceeding northwesterly along the center flow channel of Bayou Chauvin to its intersection with the straight centerline extension of Plant Road; thence continuing northwesterly along the centerline of Plant Road to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence proceeding northerly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of Morris Street; thence proceeding westerly along the centerline of Morris Street to its intersection with the centerline of Leona Street; thence proceeding northerly along the centerline of Leona Street to its intersection with the centerline of Cemetery Street; thence easterly along the centerline of Cemetery Street to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence northerly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of Furman Street, the point of beginning.

### **Precinct 35**

Beginning at the point of intersection of the centerline of Bushnell Road and Lafitte Boulevard; thence proceeding southerly along the centerline of Lafitte Boulevard to its intersection with the centerline of Baptist Circle; thence proceeding westerly and southwesterly along the centerline of Baptist Circle to its intersection with the centerline of Ethan Street; thence proceeding easterly along the centerline of Ethan Street to its intersection with the centerline of Baptist Circle; thence proceeding southerly along the centerline of Baptist Circle to its intersection with the centerline of Dawes Street; thence proceeding easterly along the centerline of Dawes Street to its intersection with the centerline of Bordelon Drive; thence northerly along the centerline of Bordelon Drive to its intersection with the centerline of Bushnell Road; thence westerly along the centerline of Bushnell Road to its intersection with the centerline of Lafitte Boulevard, the point of beginning.

### **Precinct 36**

Beginning at the intersection of the extension of the fence for the Entergy Houma substation west of Norman Street and the center flow channel of Bayou Chauvin; thence proceeding southeasterly along the center flow channel of Bayou Chauvin to its intersection with the centerline Prospect Boulevard; thence proceeding southwesterly along the centerline of Prospect Boulevard to its intersection with the centerline of Ranger Street; thence proceeding northwesterly along the centerline of Ranger Street to its intersection with the centerline of Mary Ann Avenue; thence proceeding southwesterly along the centerline of Mary Ann Avenue to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence proceeding northwesterly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of Richmond Avenue; thence proceeding northeasterly and northerly along the centerline of Richmond Avenue to its intersection with the centerline of Afton Street; thence proceeding westerly along the centerline of Afton Street to its intersection with the centerline of East Street; thence proceeding northerly along the centerline of East Street to its intersection with the centerline of Norman Street; thence proceeding northwesterly along the centerline of Norman Street to its intersection the fence for the Entergy Houma substation; thence continuing northeasterly along said fence and its extension to its intersection with Bayou Chauvin, the point of beginning.

**Precinct 38**

Beginning at the intersection with the centerlines of Saint Peter Street and Acadian Drive; thence proceeding southeasterly along the centerline of Acadian Drive to its intersection with the centerline of Louisiana Highway 661 (South Van Avenue); thence proceeding southwesterly along the centerline of South Van Avenue to its intersection with the center flow channel of Woodlawn Bayou; thence proceeding northwesterly along the center flow channel of Woodlawn Bayou to its intersection with the straight centerline extension of Saint Peter Street; thence proceeding northeasterly along the centerline of Saint Peter Street to its intersection with the centerline of Acadian Drive, the point of beginning.

**Precinct 41**

Beginning at the point of intersection of the centerlines of Louisiana Highway 57 (Grand Caillou Road) and Plant Road, and proceeding southeasterly along the centerline of Plant Road and its straight centerline extension to its intersection with the straight centerline extension to Bobbie Lou Avenue; thence proceeding southwesterly along the centerline of Bobbie Lou Avenue to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence proceeding northwesterly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of Merrill Drive; thence proceeding southwesterly along the centerline of Merrill Drive to its intersection with the centerline of Acadian Drive; thence proceeding northwesterly along the centerline of Acadian Drive to its intersection with the centerline of Saint Peter Street; thence proceeding southerly along the centerline of Saint Peter Street and its extension to its intersection with the center flow channel of Woodlawn Bayou; thence proceeding southeasterly along the center flow channel of Woodlawn Bayou to its intersection with the centerline of Louisiana Highway 661 (South Van Avenue); thence proceeding southwesterly along the centerline of Louisiana Highway 661 (South Van Avenue) to its intersection with the center flow channel of the Houma Navigation Canal; thence northerly along the center flow channel of the Houma Navigational Canal to its intersection with the center flow channel of the Intracoastal Canal; thence northerly along the center flow channel of the Intracoastal Canal to its intersection with the centerline of Louisiana Highway 3040 (Houma Tunnel); thence easterly along the centerline of Louisiana Highway 3040 (Houma Tunnel and East Tunnel Boulevard) to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence northwesterly and northerly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of Plan Road, the point of beginning.

AND

Beginning at the point of intersection of the centerlines of Louisiana Highway 24 (East Main Street) and Judith Street; thence proceeding easterly along the centerline of Louisiana Highway 24 (East Main Street) to its intersection with the centerline of Jackson Street; thence proceeding southerly along the centerline of Jackson Street to its intersection with the centerline of Tony Street; thence proceeding westerly along the centerline of Tony Street to its intersection with the centerline of Judith Street; thence proceeding northerly along the centerline of Judith Street to its intersection with the centerline of Louisiana Highway 24 (East Main Street), the point of beginning.

### **Precinct 46**

Beginning at the intersection of the centerlines of Verret Street and Louisiana Highway 312 (Lafayette Street); thence proceeding easterly along the centerline of Verret Street to its intersection with the centerline of Goode Street; thence proceeding northerly along the centerline of Goode Street to its intersection with the centerline of School Street; thence proceeding easterly along the centerline of School Street to its intersection with the centerline of Roussell Street; thence proceeding southerly along the centerline of Roussell Street to its intersection with the centerline of Academy Street; thence proceeding easterly along the centerline of Academy Street to its intersection with the centerline of Daspit Street; thence proceeding southerly along the centerline of Daspit Street to its intersection with the centerline of Louisiana Highway 3040 (Bond Street); thence proceeding easterly along the centerline of Louisiana Highway 3040 (Bond Street and the Houma Tunnel) to its intersection with the center flow channel of the Intracoastal Canal; thence southerly along the center flow channel of the Intracoastal Canal to its intersection with the straight centerline extension of Magnolia Street; thence proceeding northwesterly along the straight centerline extension of Magnolia Street to its intersection with the centerline of Louisiana Highway 182 (Barrow Street); thence proceeding northerly a short distance along the centerline of Louisiana Highway 182 (Barrow Street) to its intersection with the centerline of Dupont Street; thence proceeding northwesterly along the centerline of Dupont Street and its straight centerline extension to its intersection with Church Street; thence proceeding northerly along the centerline of Church Street to its intersection with the centerline of Margaret Street; thence proceeding westerly along the centerline of Margaret Street to its intersection with the centerline of Grinage Street; thence proceeding northerly along the centerline of Grinage Street to its intersection with the centerline of High Street; thence westerly along the centerline of High Street to its intersection with the centerline of Louisiana Highway 312 (Lafayette Street); thence northerly along the centerline of Louisiana Highway 312 (Lafayette Street) to its intersection with the centerline of Verret Street, the point of beginning.

### **Precinct 48**

Beginning at the point of intersection of the centerlines of Baratavia Avenue and Verret Street; thence easterly along the centerline of Verret Street to its intersection with the centerline of Louisiana Highway 312 (Lafayette Street); thence southerly along the centerline of Louisiana Highway 312 (Lafayette Street); to its intersection with the centerline of High Street; thence east along High Street to its intersection with Grinage Street; thence south on Grinage Street to its intersection with Margaret Street; thence east along Margaret Street to its intersection with Church Street; thence south along Church Street to its intersection with the straight centerline extension of Dupont Street; thence southeasterly along the straight centerline extension of Dupont Street to its intersection with the centerline of Louisiana Highway 182 (Barrow Street); thence southerly a short distance along the centerline of Louisiana Highway 182 (Barrow Street) to its intersection with the centerline of Magnolia Street; thence northwesterly along the centerline of Magnolia Street to its intersection with the centerline of Roussell Street; thence southeasterly along the centerline of Roussell Street to its intersection with the centerline of Sunset Avenue; thence northwesterly along the centerline of Sunset Avenue to its intersection with the centerline of Church Street; thence northeasterly along the centerline of Church Street to its intersection with the centerline of Magnolia Street; thence northwesterly along the centerline of Magnolia Street to its intersection with the centerline of

Louisiana Highway 312 (Lafayette Street); thence southerly along the centerline of Louisiana Highway 312 (Lafayette Street) to its intersection with the centerline of Louisiana Highway 311; thence westerly along the centerline of Louisiana Highway 311 to its intersection with the centerline of Barataria Avenue; thence northerly along the centerline of Barataria Avenue to its intersection with the centerline of Verret Street, the point of beginning.

## **Precinct 52**

Beginning at the point of intersection the center flow channel of the Houma Navigation Canal and the centerline of Louisiana Highway 661 (South Van Avenue); thence proceeding northeasterly along the centerline of Louisiana Highway 661 (South Van Avenue) to its intersection with the centerline of Industrial Boulevard; thence proceeding southwesterly along the centerline of Industrial Boulevard to its intersection with Louisiana Highway 57 (Grand Caillou Road); thence proceeding southerly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of Picone Road; thence proceeding westerly along the centerline of Picone Road to its intersection with the centerline of Denley Road; thence proceeding southerly along the centerline of Denley Road to its intersection with the centerline of West Woodlawn Ranch Road; thence proceeding easterly along the centerline of West Woodlawn Ranch Road to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence proceeding southerly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of Express Boulevard; thence proceeding easterly along the centerline of Express Boulevard to its intersection with the centerline of Mozart Drive; thence proceeding northerly and easterly along the centerline of Mozart Drive to its intersection with the centerline of Anaheim Drive; thence proceeding southerly along the centerline of Anaheim Drive to its intersection with the centerline of American Boulevard; thence proceeding northeasterly along the centerline of American Boulevard to its intersection with the centerline of Fallon Drive; thence proceeding southerly along the centerline of Fallon Drive to its intersection with the centerline of Fresno Drive; thence proceeding westerly along the centerline of Fresno Drive to its intersection with the centerline of Anaheim Drive; thence proceeding southeasterly along the centerline of Anaheim Drive to its intersection with the centerline of Blair Drive; thence proceeding easterly along the centerline of Blair Drive to its intersection with the centerline of Fallon Drive; thence proceeding southerly along the centerline of Fallon Drive and its straight centerline extension to its intersection with the centerline of an unnamed and unpaved access road in Ashland Landfill; thence southerly along the centerline of the unnamed and unpaved access road and its extension to its intersection with the center flow channel of the Saint Louis Canal just south of Ashland Landfill Road; thence proceeding westerly along the center flow channel of the Saint Louis Canal to its intersection with the center flow channel of an unnamed canal cut on the eastern side of the Houma Navigation Canal; thence proceeding easterly along the center flow channel of said canal to its intersection with the center flow channel of the Houma Navigation Canal; thence proceeding northerly along the center flow channel of the Houma Navigation Canal to its intersection with the centerline of Louisiana Highway 661 (South Van Avenue), the point of beginning.

### **Precinct 72**

Beginning at the point of intersection of the center flow channel of the Intracoastal Canal and the terminus of unnamed drainage ditch that originates just west of Hillard Mire Drive; thence proceeding southeasterly, northeasterly and southeasterly along the center flow channel of the unnamed drainage ditch to its intersection with the southern fence line of Crozier Drive; thence proceeding easterly along the Crozier Drive fence line to its intersection with the center flow channel of Bayou Dularge; thence proceeding southwesterly along the center flow channel of Bayou Dularge to its intersection with the centerline of an unnamed access road just south of 487 Bayou Dularge Road; thence proceeding westerly on the centerline of the unnamed access road and its extension its intersection with the center flow channel of the Intracoastal Canal; thence proceeding easterly and northeasterly along the center flow channel of the Intracoastal Canal to its intersection with the terminus of unnamed drainage ditch that originates just west of Hillard Mire Drive, the point of beginning.

### **Precinct 111**

Beginning at the point of intersection of the centerlines of Louisiana Highway 57 (Grand Caillou Road) and James Road; thence proceeding easterly along the centerline of James Road to its intersection with the centerline of Lafitte Boulevard; thence proceeding southerly along the centerline of Lafitte Boulevard to its intersection with the centerline of Baptiste Circle; thence proceeding westerly and southerly along the centerline of Baptiste Circle to its intersection with the centerline of Ethan Street; thence easterly along the centerline of Ethan Street to its intersection with the centerline of Baptiste Circle; thence proceeding southerly along the centerline of Baptiste Circle to its intersection with the centerline of Dawes Street; thence proceeding easterly along the centerline of Dawes Street to its intersection with the centerline of Bordelon Drive; thence proceeding northerly along the centerline of Bordelon Drive to its intersection with the centerline of Bushnell Road; thence proceeding easterly along the centerline of Bushnell Road to its intersection with the center flow channel of Bayou Chauvin; thence proceeding southerly along the center flow channel of Bayou Chauvin to its intersection with the straight centerline extension of Boundary Road; thence proceeding westerly along the centerline of Boundary Road to its intersection with the center flow channel of Bayou Grand Caillou; thence proceeding southerly along the center flow channel of Bayou Grand Caillou to its intersection with the centerline of East Woodlawn Ranch Road; thence proceeding easterly along the centerline of East Woodlawn Ranch Road to its intersection with the center flow channel of Bayou Chauvin; thence proceeding southerly along the center flow channel of Bayou Chauvin to its intersection with the center flow channel of the Saint Louis Canal; thence proceeding southwesterly and westerly along the center flow channel of the Saint Louis Canal to its intersection with the extension of an unnamed and unpaved roadway in the Ashland Landfill; thence proceeding northerly along the unnamed and unpaved roadway in the Ashland Landfill to its intersection the centerline extension of Fallon Drive; thence continuing northerly along the centerline extension of Fallon Drive to its intersection with the centerline of Blair Drive; thence proceeding westerly along the centerline of Blair Drive to its intersection with the centerline of Anaheim Drive; thence proceeding northerly along the centerline of Anaheim Drive to its intersection with the centerline of Fresno Drive; thence proceeding easterly along the centerline of Fresno Drive to its intersection with the centerline of Fallon Drive; thence proceeding northerly along the centerline of Fallon Drive to its intersection with American Boulevard; thence

proceeding westerly along American Boulevard to its intersection with the centerline of Anaheim Drive; thence proceeding northerly along Anaheim Drive to its intersection with Mozart Drive; thence proceeding westerly and southerly along Mozart Drive to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence proceeding northerly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with the centerline of West Woodlawn Ranch Road; thence proceeding westerly along the centerline of West Woodlawn Ranch Road to its intersection with the centerline of Denley Road; thence proceeding northerly along the centerline of Denley Road to its intersection with the centerline of Picone Road; thence proceeding easterly along the centerline of Picone Road to its intersection with the centerline of Louisiana Highway 57 (Grand Caillou Road); thence proceeding northerly along the centerline of Louisiana Highway 57 (Grand Caillou Road) to its intersection with James Road, the point of beginning.

## **District 2**

District 2 contains all of precincts 12, 17, 86, and portions of 5, 8, 9, 13, 14, 19, 20, 23, 25, 48, 51, 65, 67, 74, 76, and 84 described as follows:

Beginning at the point of intersection of the center flow channel of St. Louis Bayou and the centerline of Jolie Oaks Boulevard, thence proceeding south along the center flow channel of St. Louis Bayou to its intersection with the centerline of the Southern Pacific Railroad Tracks; thence proceeding southwesterly along the Southern Pacific Railroad Tracks to its intersection with the centerline of Louisiana Highway 20 (West Park Avenue); thence proceeding southeasterly along the centerline of Louisiana Highway 20 (West Park Avenue) to its intersection with the centerline of LSTA Court; thence proceeding easterly and southerly along the centerlines of LSTA Court and Old Hwy 659 to its intersection with the centerline of Louisiana Highway 24 (West Park Avenue); thence southerly along the centerline of Louisiana Highway 24 (West Park Avenue) to its intersection with the centerline of the extension of Louisiana Highway 311; thence proceeding westerly along the centerline of the extension of Louisiana Highway 311 to its intersection with the center flow channel of Dry Bayou; thence proceeding southerly along the center flow channel of Dry Bayou to its intersection with the center flow channel of Ouiski Bayou; thence proceeding southerly along the center flow channel of Ouiski Bayou to its intersection with the straight centerline extension of an unnamed and unpaved road approximately 1,000 feet north of Ardoyne Plantation Court; thence proceeding westerly along the centerline of the unnamed and unpaved road approximately 1,000 feet north of Ardoyne Plantation Court to its intersection with the center flow channel of Little Bayou Black; thence proceeding southerly along the center flow channel of Little Bayou Black to its intersection with the centerline of Gentle Oak Boulevard; thence proceeding southwesterly along Gentle Oak Boulevard to its intersection with the centerline of Louisiana Highway 311, thence proceeding northerly along the centerline of Louisiana Highway 311 to its intersection with the centerline of United States Highway 90; thence proceeding westerly along the centerline of United States Highway 90 to its intersection with the center flow channel of an unnamed drainage canal in Section 15, T16S-R16E; thence proceeding southerly along the center flow channel of the unnamed drainage canal to its intersection with the center flow channel of another unnamed drainage canal that is also the boundary between Section 18 and Section 19, T16S-R16E; thence proceeding southwesterly along the center flow channel of the unnamed

**PURCHASING**

All purchasing for the school system to be paid from Terrebonne Parish School Board funds shall be made by the Superintendent or his/her designee in conformance with existing regulations and procedures of the School Board and the laws pertinent to state and federal agencies. Budget allocations for specific purposes shall constitute advance School Board approval for all purchases except in such cases as state law or School Board policy may require. No debt shall be contracted in the name of the

Terrebonne Parish School Board without action by the School Board except those items which are provided for in the regular budget. No obligations shall be incurred except those approved by the Superintendent of Schools or his authorized agent. Purchases shall be made at the lowest possible cost to the school system consistent with the system specifications of quality and service. The Terrebonne Parish School Board shall not be responsible for unauthorized purchases made by school personnel.

Each principal shall assure that purchases by the individual school shall be made in accordance with applicable state and federal law, and administrative regulations and procedures developed by the Superintendent and staff.

No employee, officer, or agent of the Terrebonne Parish School Board shall participate in the selection, award, or administration of a contract or purchase of supplies, materials, and equipment if a conflict of interest, real or apparent, would be involved. Terrebonne Parish School Board employees shall neither solicit nor accept gratuities, favors, or anything of monetary value from contractors, potential contractors, or parties to sub-agreements. All purchasing shall comply with the U.S. Department of Education *General Administrative Regulations* (EDGAR), the *Louisiana Public Bid Law*, the *Louisiana Code of Governmental Ethics*, the *Louisiana Procurement Code*, and applicable state or federal regulations, as applicable.

#### USE OF FEDERAL FUNDS

All procurement of materials, supplies, and services, as well as the construction of public works, funded in whole or in part, with federal funds, shall comply with the requirements contained in Title 2, Section 200, of the Code of Federal Regulations. All procurements using federal funds, in whole or in part, shall employ one of the procedures identified in 2 CFR 200.320, if more stringent than those procedures required by Louisiana law. Should the School Board adopt the Louisiana Procurement Code, whether in part or in its entirety, the accompanying administrative regulations as promulgated in the Louisiana Procurement Code, as well as guidelines and policies issued by the Louisiana's Office of State Purchasing, relevant to the particular adoption(s) may be applicable to the purchase, if more stringent.

#### Solicitations from Small and Minority Businesses, Women's Business Enterprises, and Labor Surplus Area Firms

When spending federal funds, the Terrebonne Parish School Board shall take all necessary affirmative steps to assure that minority businesses, women's business enterprises, and labor surplus area firms are used, when possible. Affirmative steps shall include:

1. Placing qualified small and minority businesses and women's business enterprises on solicitation lists;
2. Assuring that small and minority businesses, and women's business enterprises are solicited whenever they are potential sources;
3. Dividing total requirements, when economically feasible, into smaller tasks or quantities to permit maximum participation by small and minority businesses and women's business enterprises;



4. Establishing delivery schedules, where the requirement permits, which encourage participation by small and minority businesses and women's business enterprises;
5. Using the services and assistance, as appropriate, of such organizations as the Louisiana Economic Development Agency, and Small Business Administration and the Minority Business Development Agency of the United States Department of Commerce; and
6. Requiring the prime contractor, if subcontracts are to be let, to take the affirmative steps listed in paragraphs 1 through 5 of this section.

#### Exclusion or Rejection of Quotes or Bids

A contract award or a purchase made with federal funds shall not be made to parties listed on the government-wide exclusions in the *System for Award Management* maintained by the U.S. Government, which contains the names of parties debarred, suspended, or otherwise excluded by agencies, as well as parties declared ineligible under statutory or regulatory authority.

#### USE OF STATE FUNDS

Procurement of materials and supplies when using state or locally generated funds shall follow the procurement method as authorized by Louisiana law.

#### Financing Purchases

The School Board may finance the purchase of equipment or other movable property to be used by the School Board by entering into an installment sale, lease, or similar agreement with any lender or other person. If required, such agreement shall be subject to approval of the State Bond Commission in accordance with statutory provisions. No individual school or employee shall obligate the School Board without proper school system personnel knowledge and approval.

#### Use of State Contract

If equipment, materials or supplies are available from a State of Louisiana Contract, the Superintendent and/or his/her designee may approve the purchase without using one of the purchasing procedures outlined in statutory provisions, if advantageous to the School Board.

The School Board may also *piggyback*, or purchase materials and supplies on valid contracts of other political subdivisions in accordance with La. Rev. Stat. Ann. §§33:1321-1337 or La. Rev. Stat. Ann. §38:321.1.

#### Louisiana Procurement Code

State law authorizes School Boards to adopt all or any part of the *Louisiana Procurement Code* as contained in state statutes (La. Rev. Stat. Ann. §39:1551-39:1755). For proper and efficient operations, the Terrebonne Parish School Board may adopt, by resolution or otherwise, pertinent provisions of the *Louisiana Procurement Code*, accompanying administrative regulations as promulgated in the *Louisiana Procurement Code*, as well as guidelines and policies issued by the state's Office of State Purchasing, relevant to the procurement of materials, supplies, merchandise, and other types of property.

### SOLE SOURCE PROVIDER

The School Board may award a contract for the purchase of supplies, services, or major repairs without competition when the Superintendent or designated employee has determined, in writing, that there is only one source for the supply, service, or major repair item(s) to be acquired. Pertinent procedures for purchasing such items from a sole source shall be as outlined in the State of Louisiana Office of State Purchasing's *Purchasing Rules and Regulations*.

### Qualified Group Purchasing Organizations

A *qualified group purchasing organization* means an organization, whether for profit or not for profit, of which two (2) or more public school districts are members and which solicits proposals or bids from vendors of materials, equipment, or supplies of the type and nature as may be purchased by a public school district or public school.

As provided in La. Rev. Stat. Ann. §38:2212.1, the School Board may enter into an agreement with: (A) one or more School Boards to form a qualified group purchasing organization; or (B) one or more qualified group purchasing organizations for the purchase of materials, equipment, and supplies, including installation thereof. Any such agreement shall require that the qualified group purchasing organization submit a price list for those materials, equipment, and supplies offered by it and that the prices quoted on the list remain in effect for a stated period of time of not less than three (3) months. Any such price list shall be considered, for all purposes, to be a valid and binding bid by the qualified group purchasing organization during the effective period of the agreement, and no additional bid by the qualified group purchasing organization is necessary.

The School Board may purchase materials, equipment, or supplies directly from or through a qualified group purchasing organization either if the price is less than that for the same or substantially similar materials, equipment, or supplies on the state contract or bid list, or if the same or substantially similar materials, equipment, or supplies are not under state contract or on the state bid list. Nothing included in this paragraph shall be construed to authorize the School Board to purchase materials, equipment, or supplies from or through an entity or vendor other than a qualified group purchasing organization as defined herein without using a procurement process otherwise provided by state law.

### Competitive Online Solicitation **Reverse Auction**

The School Board may use a reverse auction ~~or competitive online solicitation process on the Internet for the purchase of equipment, supplies, and other materials~~ in lieu of the more formal bid process when the School Board's procurement officer determines that the electronic bidding is more advantageous and in the best interests of the School Board. **Reverse auction means a competitive online solicitation process on the Internet for the purchase of equipment, supplies, and other materials or consulting services.**

Prior to the use of a ~~competitive online solicitation process~~ **the reverse auction**, the School Board may require that:

1. Vendors register before opening dates and time, and as part of the registration, require that the vendors agree to any terms and conditions and other requirements of the solicitation.
2. Vendors be prequalified prior to placing bids and allow only bidders who are prequalified to submit bids.
3. The solicitation shall designate an opening date and time and the closing date and time. The closing date and time may be fixed or remain open depending on the structure of the item being bid.
4. At the opening date and time, the School Board shall begin accepting online bids and continue accepting bids until the bidding is officially closed. Registered bidders shall be allowed to lower the price of their bid below the lowest bid posted on the Internet until the closing date and time.
5. Bidders' identities shall not be revealed during the bidding process; only the successively lower prices, ranks, scores, and related bid details shall be revealed.
6. All bids shall be posted electronically and updated on a real-time basis.
7. The School Board shall retain the right to cancel the solicitation if it determines that it is in the School Board's best interest.
8. The School Board shall retain its existing authority to determine the criteria that will be used as a basis for making awards.

Adequate public notice for **the purchases of materials, supplies, equipment, or consulting services** using a reverse auction ~~or competitive online solicitation process~~ shall be given as follows:

1. The advertisement or notice shall be published two (2) times in a newspaper in the locality, the first advertisement to appear at least fifteen (15) days before the opening date of the reverse auction. In addition to the newspaper advertisement, the School Board may also publish an advertisement by electronic media available to the general public.
2. The first publication of the advertisement shall not occur on a Saturday, Sunday, or legal holiday.

#### LOCAL PREFERENCE

To the extent possible, when purchasing with state or locally generated funds, all things being equal, purchases of school supplies, equipment, insurance, candy, soft drinks, etc., shall be made from dealers whose firms are located in the Parish of Terrebonne, both by individual schools and by the Terrebonne Parish School Board.

To the extent possible, when purchasing with state or locally generated funds, all things being equal, local firms shall be given preference in the awarding of contracts for construction or maintenance work. All firms awarded contracts to perform work for the Terrebonne Parish School Board shall be urged and encouraged to employ local labor, when possible.

## VENDORS

The School Board shall seek business and bids from all eligible vendors, regardless of race, creed, color, sex, national origin, age or handicap. No favoritism shall be extended to any vendor. Each order shall be placed on the basis of quality, price and delivery; past services being a factor if all other considerations are equal.

No person officially connected with or employed by the School Board shall be an agent for, or have any pecuniary or beneficial interest in or receive any compensation or reward from any vendor for the sale of supplies, materials, equipment, services, or public works contracts.

No employee of the School Board shall solicit or accept, directly or indirectly, anything of economic value as a gift or gratuity from any vendor representative or agent of a vendor, or a prospective vendor or contractor.

Vendors may set up an appointment to see the principal with written prior approval from the Superintendent/designee. The principal may present the information to the appropriate school staff member. If the school staff member wishes to set up an appointment with the vendor to discuss products offered, he or she may do so.

## **BIDS AND QUOTATIONS**

### PUBLIC WORKS

The Terrebonne Parish School Board shall advertise and let by contract, except in cases of emergencies as provided below, all public work exceeding \$250,000 or such sum as allowed by law, including labor, materials, equipment, and administrative overhead not to exceed fifteen percent (15%). The contract shall be awarded to the lowest responsible bidder who has bid according to the contract, plans, and specifications advertised. Public works, which are estimated to cost less than the contract limit, may be undertaken by the School Board with its own employees.

As an evidence of good faith of the bidder, the School Board shall require bidders for construction, improvement, repair, or other work to attach to the bid submitted, a bid bond, certified check, or cashier's check for not more than five percent (5%) of the contract work to be done. The School Board may require a bid bond or certified or cashier's check of not more than five percent (5%) of the estimated price on bids taken for supplies and materials.

When any bid is accepted for construction or doing any public works, a written contract shall be entered into by the successful bidder and the School Board, and the successful bidder shall furnish a bond in an amount not less than one-half of the amount of the contract, for the faithful performance of his or her duties.

When using state or locally generated funds, under no circumstances shall there be a division or separation of any public work project into smaller projects, which division or separation would have the effect of avoiding the requirement that public work be advertised and let by contract to the lowest responsible bidder in accordance with statutory provisions.

The School Board shall retain the option of requiring all bids that are let out for public works be submitted electronically.

### MATERIALS AND SUPPLIES

All purchases of materials or supplies exceeding the sum of \$30,000 to be paid out of public funds shall be advertised and let by contract to the lowest responsible bidder who has bid according to the specifications as advertised. In addition, purchases of materials or supplies of at least \$10,000, but not more than \$30,000, shall be made by obtaining not less than three (3) documented quotations. A written confirmation of the accepted offer shall be obtained and made a part of the purchase file. The School Board may require a written contract or bond when purchasing the materials or supplies. If quotations are received that are lower than the quote accepted, a notation shall be entered into the file as to the reasons for rejection of the lower quotes.

When using state or locally generated funds, purchases cannot be divided by departments or by a school if the effect is to evade the state's public bid law. Purchases of commodities that are bought in small but recurring amounts through the year shall be bid on an annual basis.

The School Board shall retain the option of requiring all bids that are let out for materials and supplies be submitted electronically.

In lieu of formal bids, the School Board may use a *reverse auction or competitive online solicitation process* for the purchase of equipment, supplies, and other materials **or consulting services**, as outlined in policy D-7.4, *Purchasing*.

### EMERGENCIES

In cases of an emergency or extreme emergency, when time is not sufficient to advertise for bids for public works or purchase of materials, the School Board or designee is permitted by law to declare, through resolution, that a public emergency or extreme public emergency exists and extend a contract for more than the sums mentioned without going out to bid. However, in such cases every effort shall be made by School Board personnel to secure competitive quotations. The accepted quote shall be confirmed and documented, in writing. State law permits a person designated by the School Board to declare the existence of an *extreme public emergency*. This designated person shall be the Superintendent and/or his/her designee. Notices of an *emergency* or *extreme emergency* shall be published in the School Board's official journal within ten (10) days of the emergency being certified by the School Board or designee.

An *emergency* is defined by La. Rev. Stat. Ann. §38:2211 (5)(a) as:

"An unforeseen mischance bringing with it destruction or injury of life or property or the imminent threat of such destruction or injury or as the result of an order from any judicial body to take any immediate action which requires construction or repairs absent compliance with the formalities of this Part, where the mischance or court order will not admit of the delay incident to advertising as provided in this Part."

An *extreme public emergency* is defined by La. Rev. Stat. Ann. §38:2211 (5)(b) as:

"A catastrophic event which causes the loss of ability to obtain a quorum of the members necessary to certify the emergency prior to making the expenditure to acquire materials or supplies or to make repairs necessary for the protection of life, property, or continued function of the public entity."

### BID ADVERTISEMENTS

All advertisements for bids for public works shall appear in the newspaper selected as the official journal for the School Board, except in emergencies as may be declared by the School Board. Any advertisement for any contract for public works, when published, shall appear once a week for three (3) different weeks in a newspaper in the locality and the first advertisement shall appear at least twenty-five (25) days before the opening of bids.

Any advertisement for any contract or purchase of materials or supplies shall be published two (2) times in a newspaper in the locality, the first advertisement appearing at least fifteen (15) days prior to the opening of bids.

In addition to newspaper advertisements, the School Board shall also publish advertisements and accept bids by electronic media in accordance with uniform standards promulgated by the state. In any advertisement, the first publication shall not occur on a Saturday, Sunday, or legal holiday.

If the School Board issues or causes to be issued on a public work exceeding the contract limit set by state law, any addendum modifying plans and specifications within a period of seven (7) days prior to the advertised time for opening of bids, excluding Saturdays, Sundays, and any other legal holidays, the School Board shall transmit a copy of the addendum to all prime bidders who have requested bid documents. The transmission shall be completed within twenty-four (24) hours of the issuance of the addendum, and may be delivered by either facsimile transmission (fax), e-mail, other electronic means, or by hand provided the prime bidder has supplied the fax number or e-mail address to the School Board. In addition, a copy of the addendum shall be sent by regular mail. If the addendum cannot be transmitted by fax, e-mail, other electronic means, or hand delivered, the School Board shall be required to postpone the bid opening by at least seven (7) days.

The School Board shall not issue or cause to be issued any addendum modifying plans and specifications within a period of seventy-two (72) hours prior to the advertised time for the opening of bids, excluding Saturdays, Sundays, and any other legal holidays; however, if the necessity arises to issue an addendum modifying plans and specifications within the seventy-two (72) hour period prior to the advertised time for the opening of bids, then the opening of bids shall be extended at least seven (7), but not more than twenty-one (21) working days, without the requirement of re-advertising. The addendum shall state the revised time and date for the opening of bids.

#### OPENING OF BIDS

All bids shall be opened in public in the presence of one or more witnesses, at the time and place designated in the invitation for bids. Each bid, together with the name of the bidder, shall be recorded and open to public inspection. However, the School Board shall not accept or take any bids including receiving any hand delivered bids, on days which are recognized as holidays by the United States Postal Service.

#### BID AWARD

In order to protect the integrity of the competitive bidding process, the determination of responsiveness by the bidder must be made from the bid documents at the time of the bid opening. Any deviation from or failure to supply information required by the bid documents may result in the bid being rejected as *non-responsive*.

The Superintendent and/or other appropriate administrators shall review, summarize and report bids to the School Board with recommendations for bid award unless the School Board grants permission for staff to evaluate, award, and notify the School Board at a later date.

#### DISQUALIFICATION OF BIDDER FOR NON-RESPONSIBILITY

If the School Board proposes to disqualify any bidder for *non-responsibility* (the possibility that the bidder may not satisfactorily fulfill the contract being bid), the School Board shall:

1. Give written notice of the proposed disqualification to such bidder, and include in the written notice all reasons for the proposed disqualification;

2. Give such bidder, who is proposed to be disqualified, the opportunity to be heard at an informal hearing to be conducted not later than five (5) business days after the issuance of the notice of the proposed disqualification, at which such bidder is afforded the opportunity to refute the reasons for the disqualification; and
3. Conduct the informal hearing prior to the award of the public work.

No award of the contract for the public work shall be made by the School Board prior to the expiration of at least five (5) working days following the date of issuance of the written ruling from the informal hearing.

#### EXCLUSION/REJECTION OF BIDS

The School Board, after the opening of bids, shall require each bidder or bidding entity to attest or submit an attestation that the sole proprietor, partner, incorporator, director, manager, officer, or other like individual who owns at least ten percent (10%) of the bidding entity, has not been convicted of, or has not entered a plea of guilty or nolo contendere (no contest) to any of the crimes or equivalent federal crimes listed in La. Rev. Stat. Ann. §38:2227.

In awarding bids or contracts, the School Board shall be authorized to reject the lowest bid from a business in which any individual with ownership interest of five percent (5%) or more has been convicted of, pled guilty or nolo contendere to any state felony crime or equivalent federal crime committed in the solicitation or execution of a contract or bid under the state laws governing public contracts; professional, personal, consulting, and social services procurement; or the Louisiana Procurement Code.

Any contract between the School Board and a person or entity entered into as a result of fraud, bribery, corruption, or other criminal acts, for which a final conviction has been obtained, shall be null and void.

Any person whose conviction causes the nullity of a contract shall be responsible for payment of all costs, attorney fees, and damages incurred in the rebidding of the contract.

### **LIBRARY MATERIALS SELECTION**

The School Board encourages teachers to discuss their instructional supply needs with their principal. The principal and teachers will determine an appropriate list of supplemental material based on quality, reputation and significance of author, readability and appeal, format and price.

The selection of library materials shall be in accordance with the following:

1. Library media shall be selected for values of interest and enrichment of all the school community. Library media shall not be excluded because of the race, nationality or the social, political or religious views of the authors.
2. Library media centers shall make available the fullest practical selection of media, which presents all points of view concerning problems and issues of the times.
3. The selection of materials shall provide support for the curriculum, taking into consideration the individual's needs and the varied interests, abilities, socio-economic backgrounds and maturity levels of the students served.
4. Acquisition of materials shall be guided by the reading, examination, and checking of standard evaluation aids such as standard catalogs and media review digests. Recommendations from librarians, teachers, principals, students, and other members of the school community shall be given full consideration.
5. Any censorship of media shall be challenged in order to maintain the school's responsibility to provide information and enrichment. The School Board is legally responsible for all matters relating to the operation of the library media centers. It is therefore advisable that each board adopt a written statement of procedures for meeting the challenge of censorship.

### **SELECTION AND USE OF AUDIO/VISUAL MATERIALS**

The primary objective in using audio/visual materials is to implement, enrich, and support the instructional program of the school. All such material should be shown with a purpose and relate specifically to stated goals and objectives of a given lesson.

The Board recognizes that the teachers have the primary responsibility for the selection and use of audio/visual materials in the classroom by exercising responsible judgment and selecting appropriate materials for use from

among the array of such materials available. Usage of audio-visual materials shall be in accordance with the following:

1. All AV material shall be previewed by the teacher before use with students. This includes any AV material brought in from outside sources (or presenters) for presentation to students.
2. Use of any AV materials shall be documented in lesson plans, including title and type of AV, and must directly relate to ~~objectives~~ **standards** of the lesson.
3. Movies shall be for instructional purposes only and directly related to instructional objectives as stated in lesson plans.
4. Use of any movie shall be documented in lesson plans including title of movie and appropriate introductory and follow-up activities.
5. Prior approval of the showing of any movie must be obtained from the school principal who shall be responsible for approving the appropriate introductory and follow-up activities.
6. ~~Only G-rated, and PG-rated, and PG-13 rated~~ **and PG-13 rated** movies shall **can** be shown **with the following stipulations:** ~~{PG-13 rated movies shall not be allowed}~~
  - **G-rated:** Can be shown to all grades without parental approval.
  - **PG-rated:** Can be shown to **grades 5<sup>th</sup> to 12<sup>th</sup>**, and schools shall **notify parents, in writing, of any PG-rated movie to be shown. The notification shall include the title of the movie, the rating, the purpose of showing the movie, and the date the movie will be shown.**
  - **PG-13 rated:** Can be shown only to **High School students (9<sup>th</sup>-12<sup>th</sup>)**, and schools shall **notify parents, in writing, of any PG-13 rated movie that will be shown to students, and obtain written permission from the parent for each movie to be shown. The notification shall include the title of the movie, the rating, the purpose of showing the movie, and the date the movie will be shown.**
- ~~7. Schools shall notify parents in writing of any PG-rated movie that will be shown to students and obtain written permission from the parent. The notification shall include the title of the movie, the rating, the purpose of showing the movie, and the date the movie will be shown.~~
7. Documentaries and instructional videos that are not rated shall have prior written approval from the principal or his/her designee before being shown.

No member of any school staff shall use electronic devices for his/her own recreation during the school day. Use of electronic devices shall be limited to appropriate instructional and/or administrative locations.

The implementation of this policy shall be monitored by the building principal. Violation of this policy may result in a disciplinary hearing including the employee and principal and/or Superintendent.

#### GRIEVANCE PROCEDURE RELATIVE TO LIBRARY MEDIA

Citizens shall have the right to question media materials used in the Terrebonne Parish Public School System. If a citizen has a complaint, he/she must report it to the principal of the school where the material is in question. The principal shall give the citizen a copy of "Guidelines for the Selection of Library Media." If, after reading the state's guidelines, the citizen wishes to pursue his/her complaint, he/she shall be given a form to register his/her complaint and present it to the principal for consideration.
