#### PROCEEDINGS OF THE TERREBONNE PARISH SCHOOL BOARD

## September 6, 2011

The Terrebonne Parish School Board met today at 7:00 P.M. in regular session at its regular meeting place, the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana, with Mr. L. P. Bordelon, III, President, presiding, and the following members present: Mr. Roosevelt Thomas, Vice-President, Mr. Gregory Harding, Mr. Richard Jackson, Ms. Brenda Leroux Babin, Mr. Roger Dale DeHart, Mr. Donald Duplantis, and Mr. Hayes J. Badeaux.

ABSENT: Ms. Debi Benoit

Mr. Thomas led the Board and audience in the invocation and Pledge of Allegiance to the Flag.

Motion of Mr. Thomas, seconded by Ms. Babin, unanimously carried, the Board approved the minutes of School Board Meeting of August 16, 2011, as recorded.

The following report of the Finance, Insurance, and Section 16 Lands Committee meeting was presented to the Board with Mr. Duplantis, Chairman, presiding:

Dear Members of the Board:

**The FINANCE, INSURANCE, and SECTION 16 LANDS COMMITTEE** met in the Board Room of the School Board Office, 201 Stadium Drive, at 5:00 P.M. on Monday, August 15, 2011, with the following members present: Mr. Donald Duplantis, Chairman, Mr. Roosevelt Thomas, Vice-Chairman, and Ms. Debi Benoit. Also in attendance were Superintendent Philip Martin and members of the staff.

Mr. Duplantis called the meeting to order. The meeting began with the invocation and Pledge of Allegiance to the Flag.

Mr. Len Fontaine, Terrebonne Parish School Board Group Health Plan Broker, addressed the Committee relative to the Patient Protection and Affordable Care Act (PPACA). Mr. Fontaine discussed the following provisions that apply to all self-funded plans for plan years beginning on or after September 23, 2010: Pre-existing condition exclusion for children under age 19, coverage for adult children, no lifetime limits on essential health benefits, rescission of coverage, no annual limits on essential benefits, W-2 reporting of value of benefits, no reimbursement for over-the-counter drugs, and early retiree reinsurance program.

Mr. Jack Moore addressed the Committee concerning Group Health Claims History. He stated group medical claims have increased but group prescription claims have decreased due to the benefit changes that took place in May of 2011.

Mr. Moore presented the Committee with the Casualty Claims Summary. He indicated the automobile, general, and Board of Education liability all have open claims at this time.

Mr. Moore addressed the Committee concerning the Workers' Compensation Claims Summary. He presented reports regarding Workers' Compensation claims for expense categories, job function, and by location.

Mr. Harris Henry presented the Fiscal Year 2010/2011 Louisiana Compliance Questionnaire.

Ms. Benoit, seconded by Mr. Thomas, offered the following motion:
