#### PROCEEDINGS OF THE TERREBONNE PARISH SCHOOL BOARD

#### June 7, 2011

The Terrebonne Parish School Board met today at 7:00 P.M. in regular session at its regular meeting place, the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana, with Mr. L. P. Bordelon, III, President, presiding, and the following members present: Mr. Roosevelt Thomas, Vice-President; Mr. Richard Jackson, Ms. Brenda Leroux Babin, Mr. Roger Dale DeHart, Mr. Donald Duplantis, and Mr. Hayes J. Badeaux.

ABSENT: Mr. Gregory Harding and Ms. Debi Benoit (Ms. Benoit is out-of-the country.)

Mr. DeHart led the Board and audience in the invocation and Pledge of Allegiance to the Flag.

A moment of silence was observed in memory of Marjorie Mathes, retired school teacher; Ruby Carter, retired school food service employee, and Joann Gillies, retired school bus driver, who recently passed away.

Motion of Mr. Badeaux, seconded by Mr. Thomas, unanimously carried, the Board approved the minutes of School Board Meeting of May 17, 2011, as recorded.

President Bordelon gave introductions and Superintendent Philip Martin presented plaques and certificates to three of Terrebonne Parish's 2010-2011 Outstanding School Support Employees: Susie Slaughter, Paraprofessional at Dularge Middle School, Elementary School Level; Eddie Jones, Custodian at Caldwell Middle School, Middle/Junior High School Level, and Rebecca Labat, School Secretary at H. L. Bourgeois High School, High School Level.

The following report of the Finance, Insurance, and Section 16 Lands Committee meeting was presented to the Board with Mr. Duplantis, Chairman, presiding:

Dear Members of the Board:

**The FINANCE, INSURANCE, and SECTION 16 LANDS COMMITTEE** met in the Board Room of the School Board Office, 201 Stadium Drive, at 5:00 P.M. on Monday, May 16, 2011, with the following members present: Mr. Donald Duplantis, Chairman, Mr. Roosevelt Thomas, Vice-Chairman, and Ms. Debi Benoit. Also in attendance were Mr. L. P. Bordelon, III, Board President, Mr. Richard Jackson, Superintendent Philip Martin, and members of the staff.

Mr. Duplantis called the meeting to order. The meeting began with the invocation and Pledge of Allegiance to the Flag.

Mr. Harris Henry stated there were no seismic permits.

Mr. Jack Moore discussed the matter bearing upon Boiler and Machinery Insurance renewal.

The following motion was offered by Mr. Thomas, seconded by Ms. Benoit, with the objection of Ms. Benoit:

### **RECOMMENDATION NO. 1**

**The Committee recommends** that the Board accept the proposal for Boiler and Machinery Insurance from Travelers Insurance Company (Arthur J. Gallagher of Louisiana, Inc., Broker of Record), with an annual premium of \$14,325.00, subject to a \$2,500.00 deductible, effective July 1, 2011.

Mr. Moore then reviewed the Flood Insurance renewal.

Mr. Duplantis requested that the Board receive price information on flood insurance for Bayou Black Elementary and Greenwood Middle Schools before the next School Board meeting.

The following motion was offered by Mr. Thomas, and seconded by Ms. Benoit:

# **RECOMMENDATION NO. 2**

**The Committee recommends** that the Board authorize the renewal of Flood Insurance with Fidelity National (Ledet Agency, Inc., Broker of Record), as per the attached schedule, including the "old" Grand Caillou Elementary site with the National Flood Insurance Program, effective July 1, 2011, with a total annual premium for all locations of \$121,647.00.

Mr. Moore discussed the Student Accident Insurance renewal.

The following motion was offered by Ms. Benoit, seconded by Mr. Thomas, with Ms. Benoit abstaining:

# **RECOMMENDATION NO. 3**

The Committee recommends that the Board accept the proposal from Marc Harris (Agent of Record), underwritten by Monumental Life Insurance Co., for Student Accident Insurance, including Catastrophic Athletic Accident Insurance and Volunteer Workers with limits of \$1,000,000.00 per student accident and \$25,000.00 per volunteer accident, effective August 1, 2011, with an annual premium of \$156,550.00.

Superintendent Martin introduced the proposed Original Operating Budgets for Fiscal Year 2011/2012.

The following motion was offered by Ms. Benoit, and seconded by Mr. Thomas:

**The Committee recommends** that the Board receive the Original Proposed 2011/2012 Budgets and establish a public hearing on same: Monday, June 20, 2011, at 6:00 P.M. in the Board Room of the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana.

Mr. Henry updated the Committee on the Sales Tax collections report. He said sales tax collections for the month of March 2011 are higher than March 2010.

There being no further business to come before the **Finance**, **Insurance**, **and Section 16 Lands Committee**, motion of Mr. Thomas, seconded by Ms. Benoit, the meeting adjourned at 5:50 P.M.
