# PROCEEDINGS OF THE TERREBONNE PARISH SCHOOL BOARD

#### December 2, 2014

The Terrebonne Parish School Board met today at 6:00 P.M. in regular session at its regular meeting place, the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana, with Mr. Roger Dale DeHart, President, presiding, and the following members present: Mr. Richard Jackson, Vice-President; Mr. Gregory Harding, Dr. Brenda Leroux Babin, Mr. L.
