The EDUCATION, TECHNOLOGY, and POLICY COMMITTEE met at 5:00 P.M. on Monday, June 1, 2015, in the Board Room of the School Board Office, with the following members present: Dr. Brenda Leroux Babin, Chairwoman, Mr. L. P. Bordelon, III, Vice-Chairman, and Mrs. Vicki Bonvillain. Also in attendance were Mr. Donald Duplantis, Superintendent Philip Martin, and members of the staff.

Dr. Babin called the meeting to order. The meeting began with the invocation and Pledge of Allegiance to the Flag.

Mr. Alton Johnson, Supervisor of Child Welfare and Attendance, presented information on Terrebonne Parish School Board's partnership with the Terrebonne Parish Sheriff's Office and the "Reality Check" Program. Mr. Johnson stated that the Program provides behavioral intervention. Part of the Program includes a tour of the Terrebonne Parish Correctional Facility (see attached).

Sheriff Jerry Larpenter, Terrebonne Parish, stated that the "Reality Check" Program has shown a drop in youth crime since its introduction and explained that the Program is not a scare tactic, but a lesson on reality. He hopes to expand the Program in the coming year.

Mr. Chris Stewart, Director of Terrebonne SPARC, presented information on the Single Point Assessment and Resource Center (SPARC) located at 8326 Main Street, Building 10, Houma, LA. Their goal, in partnering with the Terrebonne Parish School System, Terrebonne Parish Consolidated Government, Terrebonne Parish Sheriff's Office, and District Attorney's Office, is to deter students from the Juvenile Detention Center by providing resources and services to improve mental health and substance abuse for juveniles and families of Terrebonne Parish (see attached).

Ms. Kim Vauclin, Supervisor of Child Welfare and Attendance, presented information on the *Critical Incident Workshop* that will take place during the month of June at Terrebonne High School. She stated the Workshop will discuss law enforcement role, teacher role, classroom security, school security, safe area operations, and post incident investigations (see attached).

Ms. Mary Aucoin, Supervisor of Special Education, proposed renewing the Interagency Agreement between Terrebonne Parish School Board and the Terrebonne Parish Head Start Program for the 2015-2016 School Year (see attached).

- 3) Use of the Superintendent and staff would reduce the cost of the S/P dramatically. The original Study cost was \$165,000 (+/-).
- 4) The S/P would include priorities, costs, timelines, etc.
- 5) Board Member input would be solicited.
- 6) The Board would be constantly apprised of the progress of the S/P.
- 7) Community and parent input would be solicited.
- 8) Form a Task Force

A roll call vote having been called for on the second amendment to the original motion which would include the eight points of rationale, the vote thereon was as follows:

YEAS: Mr. Thomas, Mr. Harding, Dr. Babin, Mr. Bordelon, and Ms. Bonvillain

NAYS: Mr. Jackson, Mr. DeHart, and Mr. Duplantis

ABSENT: Ms. Benoit

President Thomas declared the foregoing second amendment to the motion carried.

A roll call vote then having been called for on the original motion, as amended, that the Board authorize the Superintendent and appropriate staff members, using the 2005 Facility Study as a BASIS, to present to the Buildings, Food Service, and Transportation Committee in September an updated Facility Study with recommendation for a plan of action for implementation, including the following eight points of rationale presented, the vote thereon was as follows:

- 1) The Study/Plan (S/P) would be directed by the Superintendent and staff using the people that best know the physical facilities and curricular needs of the system.
- 2) The Superintendent would be empowered to seek any outside expertise on any aspect, as needed.
- 3) Use of the Superintendent and staff would reduce the cost of the S/P dramatically. The original Study cost was \$165,000 (+/-).
- 4) The S/P would include priorities, costs, timelines, etc.
- 5) Board Member input would be solicited.
- 6) The Board would be constantly apprised of the progress of the S/P.
- 7) Community and parent input would be solicited.
- 8) Form a Task Force
