PROCEEDINGS OF THE TERREBONNE PARISH SCHOOL BOARD

February 2, 2016

The Terrebonne Parish School Board met today at 6:00 P.M. in regular session at its regular meeting place, the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana, with Mr. Roger Dale DeHart, President, presiding, and the following members present: Mr. L. P. Bordelon, III, Vice-President, Mr. Roosevelt Thomas, Mr. Richard Jackson, Dr. Brenda Leroux Babin, Mr. Donald Duplantis, and Ms. Vicki Bonvillain.

ABSENT: Mr. Gregory Harding and Ms. Debi Benoit

Mr. Duplantis led the Board and audience in the invocation and Pledge of Allegiance to the Flag.

A moment of silence was observed in memory of Glen McGuire, retired school teacher, and Edna Pate, retired school teacher, who recently passed away.

Motion of Mr. Duplantis, seconded by Mr. Thomas, unanimously carried, the Board approved the minutes of School Board Meetings of January 5, 2016, and January 19, 2016, as recorded.

At this time, President DeHart recognized members of Leadership Terrebonne who were in attendance at tonight's meeting.

At this time, the Board recognized Mr. Roosevelt Thomas, outgoing Board President, and presented a plaque to him in appreciation for his services rendered as President of the Terrebonne Parish School Board for the past year (2015).

Mr. Thomas gave brief remarks thanking the Board for the assistance given to him while he served as President of the Terrebonne Parish School Board. He stated it was a challenging year.

Several announcements were then made by President DeHart relative to upcoming meetings.

The following report of the Finance, Insurance, and Section 16 Lands Committee meeting was presented to the Board with Mr. Duplantis, Chairman, presiding:

The FINANCE, INSURANCE, and SECTION 16 LANDS COMMITTEE met in the Board Room of the School Board Office, 201 Stadium Drive, at 5:00 P.M. on Monday, January 25, 2016, with the following members present: Mr. Donald Duplantis, Chairman, Mr. Roosevelt Thomas, Vice-Chairman, and Dr. Brenda Leroux Babin. Also in attendance were Mr. Roger Dale DeHart, Board President, Mr. L. P. Bordelon, III, Vice-President, Superintendent Philip Martin, and members of the staff.

Chairman Duplantis called the meeting to order. The meeting began with the invocation and Pledge of Allegiance to the Flag.

Mr. Mark Felger, Lanaux & Felger, CPA, presented the Committee with a PowerPoint presentation regarding the June 30, 2015, Terrebonne Parish School Board Audit Report. He stated the financial statements ending June 30, 2015, had received an "unmodified opinion," which is the best possible rating. Mr. Felger briefly explained the internal control, compliance, independent accountant reports, and the required communication letter.

Dr. Babin, seconded by Mr. Thomas, offered the following motion:

RECOMMENDATION NO. 1

The Committee recommends that the Board receive the June 30, 2015, Terrebonne Parish School Board Audit Report, as presented.

Ms. Carolyn Champagne, Purchasing Agent, addressed the Committee regarding the bid results (attached) for the sale of the surplus property located at 1505 East Tunnel Blvd., Houma, LA 70363 (Honduras/Walgreens Property).

Dr. Babin, seconded by Mr. Thomas, offered the following motion: that the Board accept the highest bid received, meeting all specifications, for the sale of surplus property located at 1505 East Tunnel Blvd., Houma, LA 70363 (Honduras/Walgreens Property), from Financial Packaging Companies, 6 Hidden Ledge Road, Englewood, NJ 07631, in the amount of \$200,000.00, pending Board Attorney review and approval, and further, authorize the Board President to sign all necessary documents pertaining thereto; proceeds to be deposited in the Building Fund and designated for future building projects.

Following discussion, Mr. Thomas, seconded by Dr. Babin, with the exception of Chairman Duplantis who objected, offered the following substitute motion:

RECOMMENDATION NO. 2

The Committee recommends that the Board accept the highest bid received, meeting all specifications, for the sale of surplus property located at 1505 East Tunnel Blvd., Houma, LA 70363 (Honduras/Walgreens Property), from Financial Packaging Companies, 6 Hidden Ledge Road, Englewood, NJ 07631, in the amount of \$200,000.00, pending Board Attorney review and approval, and further, authorize the Board President to sign all necessary documents pertaining thereto; \$50,000.00 of the proceeds will be designated to Honduras Elementary School and the remaining \$150,000.00 of the proceeds to be deposited in the Building Fund and designated for future building projects.

Ms. Breaux presented an update on the Sales Tax collections report (attached). She stated sales tax collections for the month of November 2015 are approximately 10% lower than November 2014.

There being no further business to come before the **Finance**, **Insurance**, **and Section 16 Lands Committee**, motion of Mr. Thomas, seconded by Dr. Babin, the meeting adjourned at 5:32 P.M.

Mr. Thomas, seconded by Dr. Babin, offered a second substitute motion, that the Board accept the highest bid received, meeting all specifications, for the sale of surplus property located at 1505 East Tunnel Blvd., Houma, LA 70363 (Honduras/Walgreens Property), from Financial Packaging Companies, 6 Hidden Ledge Road, Englewood, NJ 07631, in the amount of \$200,000.00, pending Board Attorney review and approval, and further, authorize the Board President to sign all necessary documents pertaining thereto; \$16,000.00 of the proceeds (\$8,000.00 for 2016, and \$8,000.00 for 2017) will be designated to Honduras Elementary School and the remaining \$184,000.00 of the proceeds to be deposited in the Building Fund and designated for future building projects.
