Mrs. Solet led the Board and audience in the invocation and Pledge of Allegiance to the Flag.

A moment of silence was observed in memory of Beldina U. Williams, retired school food service technician; Una W. Pesnell, retired school teacher, and Jane V. LeBoeuf, retired school food service technician, who recently passed away.

Motion of Mrs. Solet, seconded by Mr. Hamner, unanimously carried, the Board approved the minutes of School Board Meeting of February 4, 2020, as recorded.

Several announcements were made by President Benoit relative to upcoming meetings.

The following report of the Finance, Insurance, and Section 16 Lands Committee meeting was presented to the Board with Mr. Hamner, chairman, presiding:

The FINANCE, INSURANCE, AND SECTION 16 LANDS COMMITTEE met at 5:00 P.M. on Tuesday, February 18, 2020, in the Board Room of the School Board Office with the following members present: Mr. Clyde Hamner, chairman, Mr. Michael LaGarde, vice chairman, and Mrs. Stacy Solet. Also in attendance were Mrs. Debi Benoit, Board president, Mr. Dane Voisin, Dr. MayBelle Trahan, Mr. Roger Dale DeHart, Mr. Matthew Ford, Superintendent Philip Martin, and members of the staff.

Chairman Hamner called the meeting to order. The meeting began with the invocation and Pledge of Allegiance to the Flag.

Chairman Hamner addressed the Committee regarding Property Insurance Renewal for 2020/2021.

RECOMMENDATION NO. 1

The Committee recommends that the Board accept the renewal offer for Property Insurance through USI Insurance Services, Inc., providing \$50 million limits per occurrence with \$12 million sub-limits for Named Storms, subject to \$100,000 deductible per occurrence for all perils except for a three percent (3%) deductible subject to \$500,000 minimum per occurrence for Named Storms, effective April 27, 2020, with an annual premium of \$1,047,311.

Mr. Curtis Constrantiche, Purchasing Agent, addressed the Committee regarding approval to advertise for bids on Hunting and Trapping Leases.

RECOMMENDATION NO. 2

The Committee recommends that the Board authorize the Purchasing Department to advertise for bids on Hunting and Trapping Leases that are currently available and/or may become available during the annual renewal period.

Chairman Hamner presented information on a Monthly Budget-to-Actual Comparison report (attached).

Chairman Hamner presented an update on the Sales Tax collections report (attached). He stated that sales tax collections for the month of December 2019 are approximately 2% higher than December 2018.

The following report of the Education, Technology, and Policy Committee meeting was presented to the Board with Dr. Trahan, chairwoman, presiding:

Dear Members of the Board:

The EDUCATION, TECHNOLOGY, and POLICY COMMITTEE met on Tuesday, February 18, 2020, immediately following the 5:00 P.M. Finance, Insurance, and Section 16 Lands Committee; and the Executive Committee in the Board Room of the School Board Office with the following members present: Dr. MayBelle Trahan, chairwoman, Mr. Matthew Ford, vice chairman, and Mrs. Debi Benoit. Also in attendance were Mrs. Stacy Solet, Board vice president, Mr. Clyde Hamner, Mr. Roger Dale DeHart, Mr. Dane Voisin, Superintendent Philip Martin, and members of the staff.

Chairwoman Trahan called the meeting to order.

Mr. Nathan Cotten, STEM Curriculum Specialist, introduced Adrianna Adams, South Terrebonne High School Environmental Science Teacher, who presented information on Project Resilience. The project enables students to develop short- and long-term resilience plans for their communities in response to environmental impacts their region is experiencing, including flooding and coastal erosion. The project is funded through a grant from the National Academies of Sciences, which was awarded to the University Corporation for Atmospheric Research (UCAR) Center for Science Education. The Wetlands Discovery Center has worked closely with UCAR to develop the curriculum that is being implemented in the Environmental Science classes at our four high schools. Mrs. Adams stated that South Terrebonne High School is implementing Project NOAA (National Oceanic Atmospheric Administration) which studies destructive hurricanes and tropical storms of the past. Based on collected data, their goal is to predict what magnitude of destruction one would cause within our area, considering coastal erosion and land loss.

Mr. Cotten presented information on the 44th Annual Terrebonne Science and Engineering Fair that was held January 14-15, 2020, at the Houma Municipal Auditorium. A total of nine (9) schools, compiled of grades 6-12, competed. Top schools in each division were Houma Jr. High School and Terrebonne High School. Twenty-three (23) students qualified to compete at the state level in March, and two (2) students qualified to compete at the international level in May.

Mr. Cotten presented information on the Louisiana FIRST LEGO League (FLL) State Tournament. Five (5) teams from Broadmoor Elementary School, Lacache Middle School, Legion Park Elementary School, Mulberry Elementary School, and Upper Little Caillou Elementary School; and two (2) teams from Oakshire Elementary School qualified to compete. Team Bayou Bots from Broadmoor Elementary School placed in the top fifteen (15) teams out of sixty (60) that participated. Eighteen (18) K-8 schools in Terrebonne Parish have LEGO robots at their site.

There being no further business to come before the **Education**, **Technology**, **and Policy Committee**, the meeting adjourned at 5:41 P.M.
