### PROCEEDINGS OF THE TERREBONNE PARISH SCHOOL BOARD

## June 2, 2020

The Terrebonne Parish School Board met today at 6:00 P.M. in regular session at its regular meeting place, the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana, with Mrs. Debi Benoit, president, presiding, and the following members present: Mrs. Stacy V. Solet, vice president; Mr. Michael T. LaGarde, Mr. Matthew J. Ford, Mr. Clyde F. Hamner, Mr. Roger Dale DeHart, Dr. MayBelle N. Trahan, and Mr. Dane Voisin.

ABSENT: Mr. Gregory Harding

Mr. Ford led the Board and audience in the invocation and Pledge of Allegiance to the Flag.

A moment of silence was observed in memory of James E. Charles, retired Terrebonne Parish School Board Superintendent; Ronald J. Foret, retired school principal at Caldwell Middle School; Ardieth D. Augustine, retired special education secretary; James U. English, retired school teacher, and Gwendolyn L. Wallace, retired school paraprofessional, who recently passed away.

Several announcements were made by President Benoit relative to upcoming meetings.

Motion of Mr. Hamner, seconded by Mrs. Solet, with the exception of Mr. Ford and Mr. DeHart who objected, the Board selected *The Courier* to serve as the Official Journal for the Terrebonne Parish School Board, at current rates, from July 1, 2020, through June 30, 2021.

Motion of Mr. DeHart, seconded by Dr. Trahan, unanimously carried, the Board accepted the offer from Companion Life Insurance Company (Alford and Associates, Broker) for a two (2) year extension, through September 30, 2023, of the current Term Life Insurance agreement (October 1, 2018, through September 30, 2021), under current terms and conditions, except to include a ten percent (10%) reduction to Retiree Optional Life rates, effective August 1, 2020.

Motion of Mr. DeHart, seconded by Mr. Voisin, unanimously carried, the Board authorized the renewal of Flood Insurance with Ledet Agency, Inc., through Wright National Flood Insurance Company, effective July 1, 2020, with an estimated annual premium in the amount of \$160,186.00.

Motion of Mr. DeHart, seconded by Mrs. Solet, unanimously carried, the Board accepted the lowest bid received, meeting all specifications, for Fuels and Automated Dispensing Services from FleetCor Technologies Operating Company, LLC, dba Fuelman, 3280 Peachtree Road, Suite 2400, Atlanta, Georgia 30305, for a three (3) year period beginning July 1, 2020, and ending June 30, 2023, with the option to renew for two (2) additional three (3) year periods under the same terms and conditions.
