Also in attendance were Mrs. Stacy Solet, Mr. Clyde Hamner, Mr. Dane Voisin, Mr. Roger Dale DeHart, Superintendent Philip Martin, and members of the staff.

Chairwoman Benoit called the meeting to order.

Mr. Bubba Orgeron, Assistant Superintendent, presented information on Terrebonne Parish School District's Summer Learning and Enrichment Program (attached). The program will be offered Monday-Thursday from 9 a.m. to 1 p.m. for four (4) weeks with each week based on a theme; June 21-24, 2021 (Launch to Outer Space), June 28 - July 1, 2021 (Be a Super Hero), July 6-8, 2021 (Team USA), and July 12-15, 2021 (Mix it Up). The program will be held at Village East Elementary, Oakshire Elementary, Southdown Elementary, Grand Caillou Middle, and Houma Jr. High Schools. The program is open to all students in grades K-8. Students can register online via www.tpsd.org.

Mr. Orgeron presented information on 2021 high school graduations. He stated graduations will be held in Terrebonne High School's stadium, weather permitting, for Terrebonne High School and H. L. Bourgeois High School; each graduate will receive nine (9) entrance tickets. Likewise, graduations will be held in South Terrebonne High School's stadium, weather permitting, for South Terrebonne High School and Ellender Memorial High School; each graduate will receive ten (10) entrance tickets. Entrance tickets are based on stadium capacity of parents/guests, graduates, and District employees.

Mr. Orgeron presented information on the 45th Annual Terrebonne Parish Science and Engineering Fair that was held virtually on February 9-10, 2021, at the Houma Municipal Auditorium (attached). Seventy-four (74) students from ten (10) schools (middle, junior high, and high combined) participated in the fair with a total of seventy (70) projects. Seventeen (17) students had the opportunity to compete at the State level; ten (10) of those students took home ribbons of placement.

Mr. Orgeron presented information on Terrebonne Foundation for Academic Excellence (TFAE) Grants (attached). He stated, eighty-two (82) grants, worth approximately \$66,000, were presented to Terrebonne Parish School District teachers. The Committee expressed their gratitude for the generous opportunities afforded to our schools, teachers, and students through TFAE.

Mr. Orgeron stated eleven (11) students were nominated by their schools and honored as TFAE Distinguished Scholars. Each Scholar then named their Inspirational Educator, a teacher who has provided encouragement and inspiration in their life (attached).

Mr. Orgeron presented information on the 2021-2022 Principal of the Year State Semi-Finalist, Mr. Darrell Dillard, from Ellender Memorial High School. Mr. Dillard was chosen by his peers, for this prestigious honor, as the 2021-

2022 High School Principal of the Year. The Committee wishes to congratulate Mr. Dillard for his dedication to Terrebonne Parish Schools and hard work ethics.
